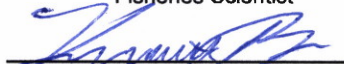
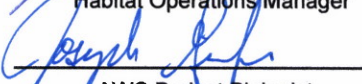

 While conducting presence/absence fish surveys in the Johnson River valley, Beth Evers (ADFG) and I captured several Dolly Varden using a backpack efisher and net. Two of the DV were large and in spawning condition. Anadromous DV have been observed spawning in the Johnson River. The DV we captured measured: 400 (male), 300 (female), 65, 88, 125, and 180 mm.

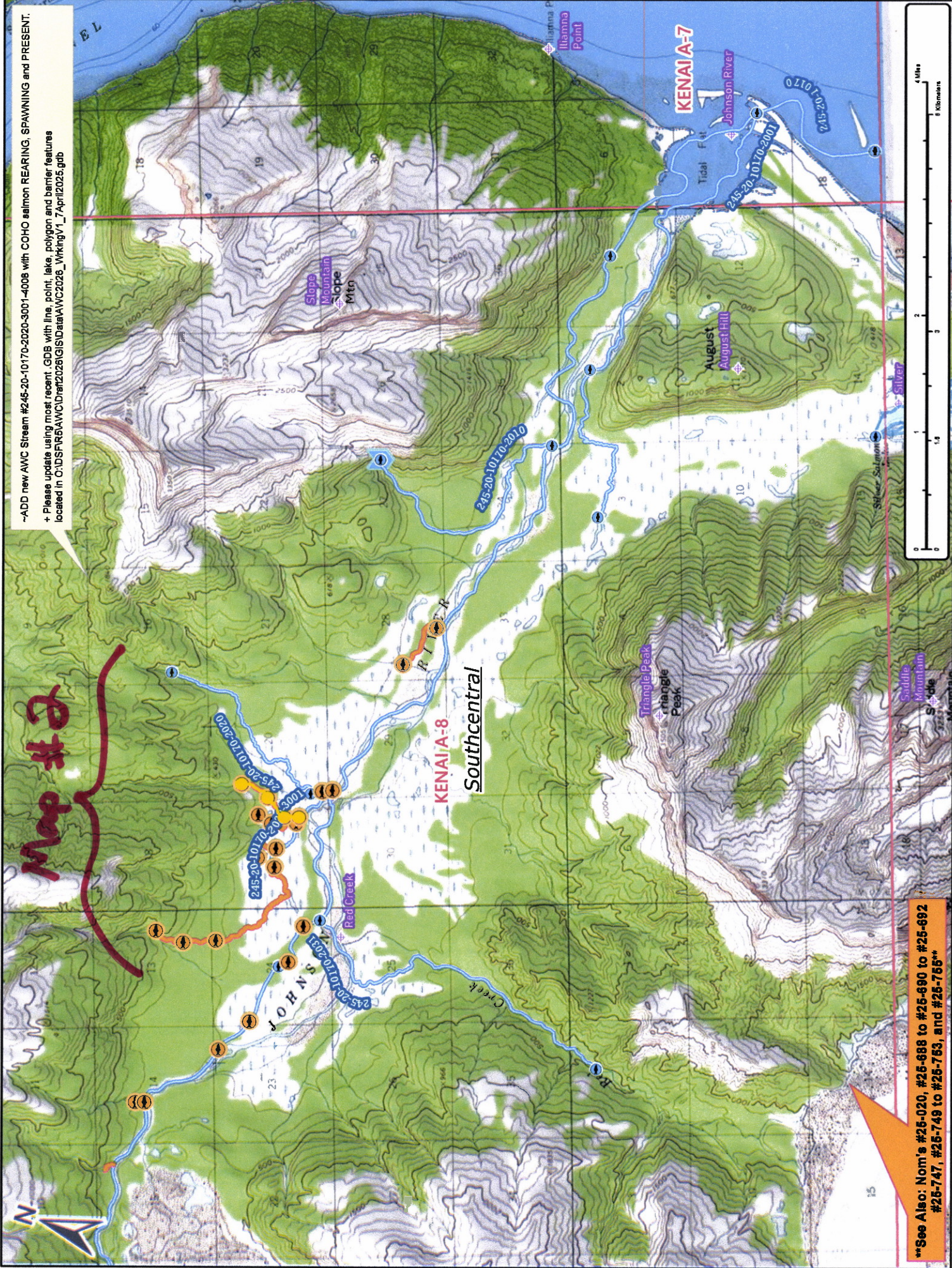

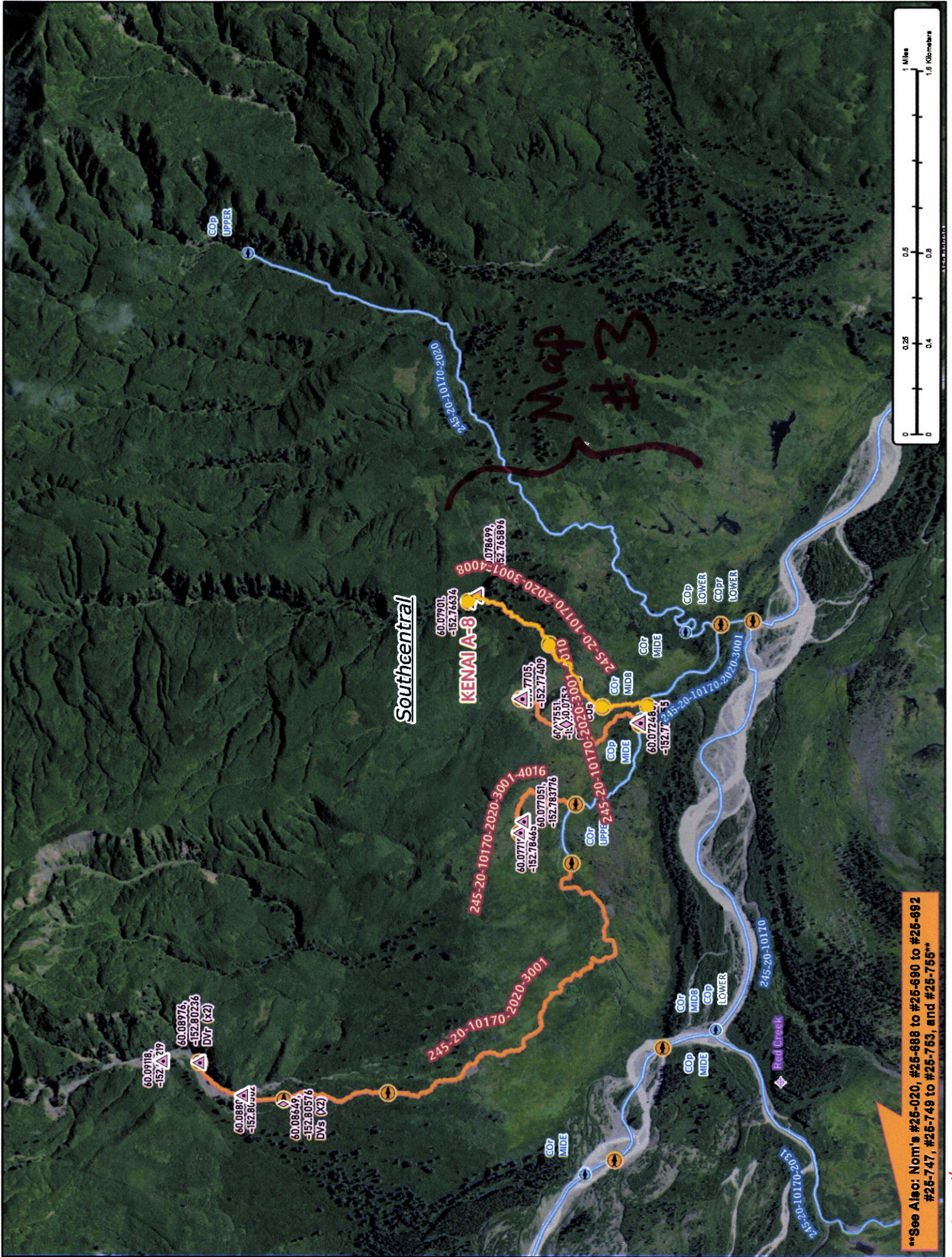

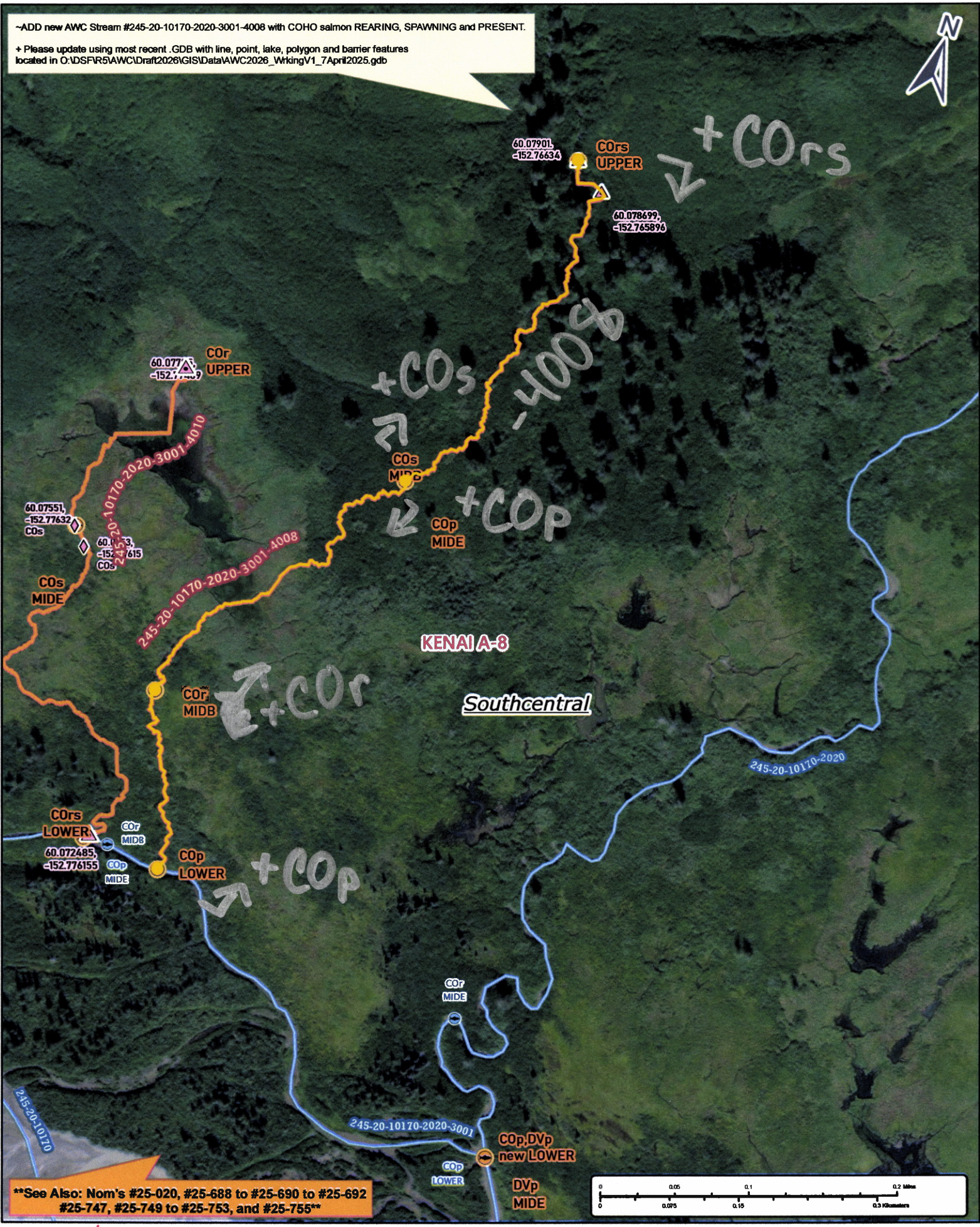
