Findings: We surveyed this uncataloged stream from the road using baited minnow traps and GPS and captured juvenile coho salmon (Figure 1). The stream is moving slowly through a ditched channel (Table 1; Figures 2, 3).

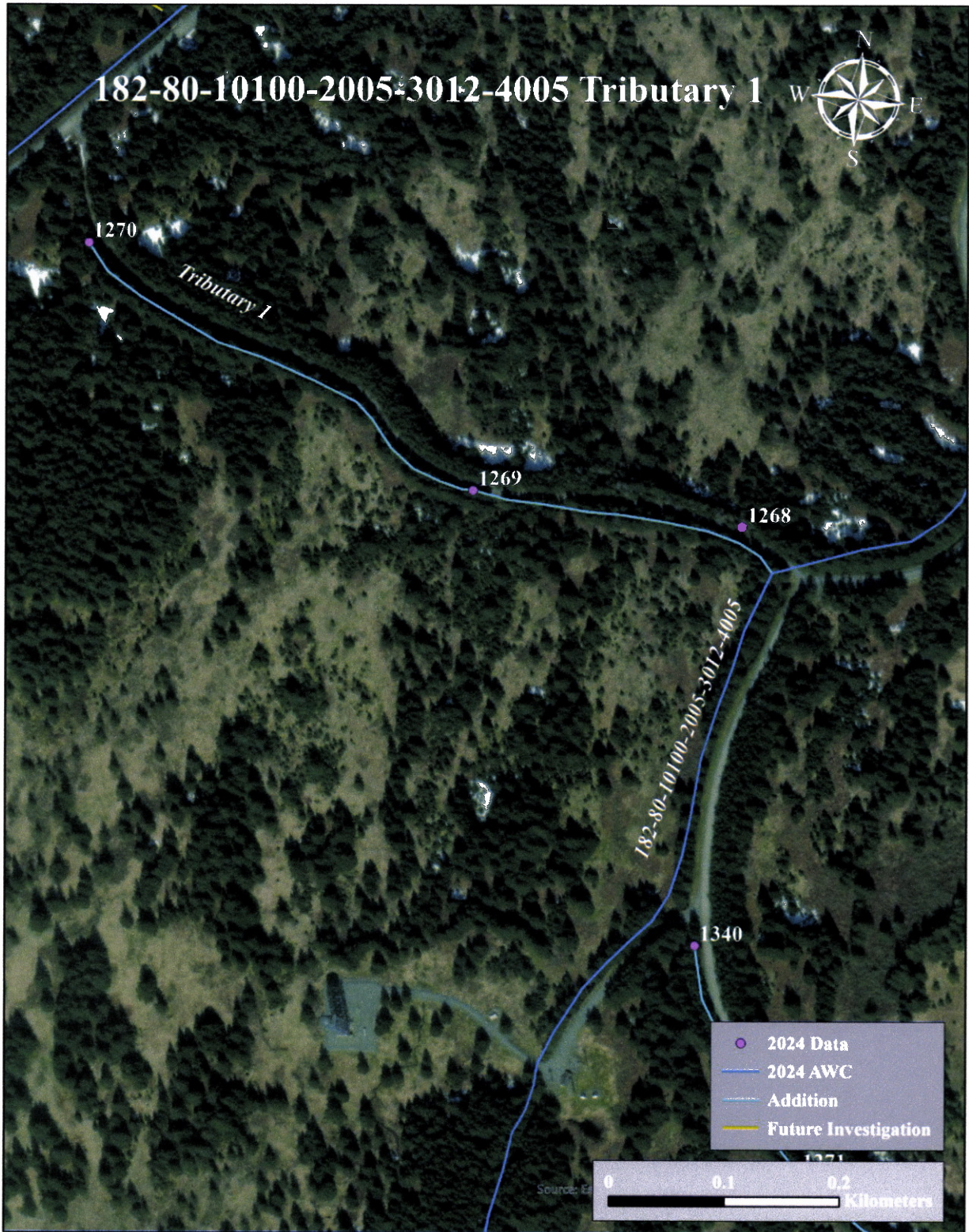
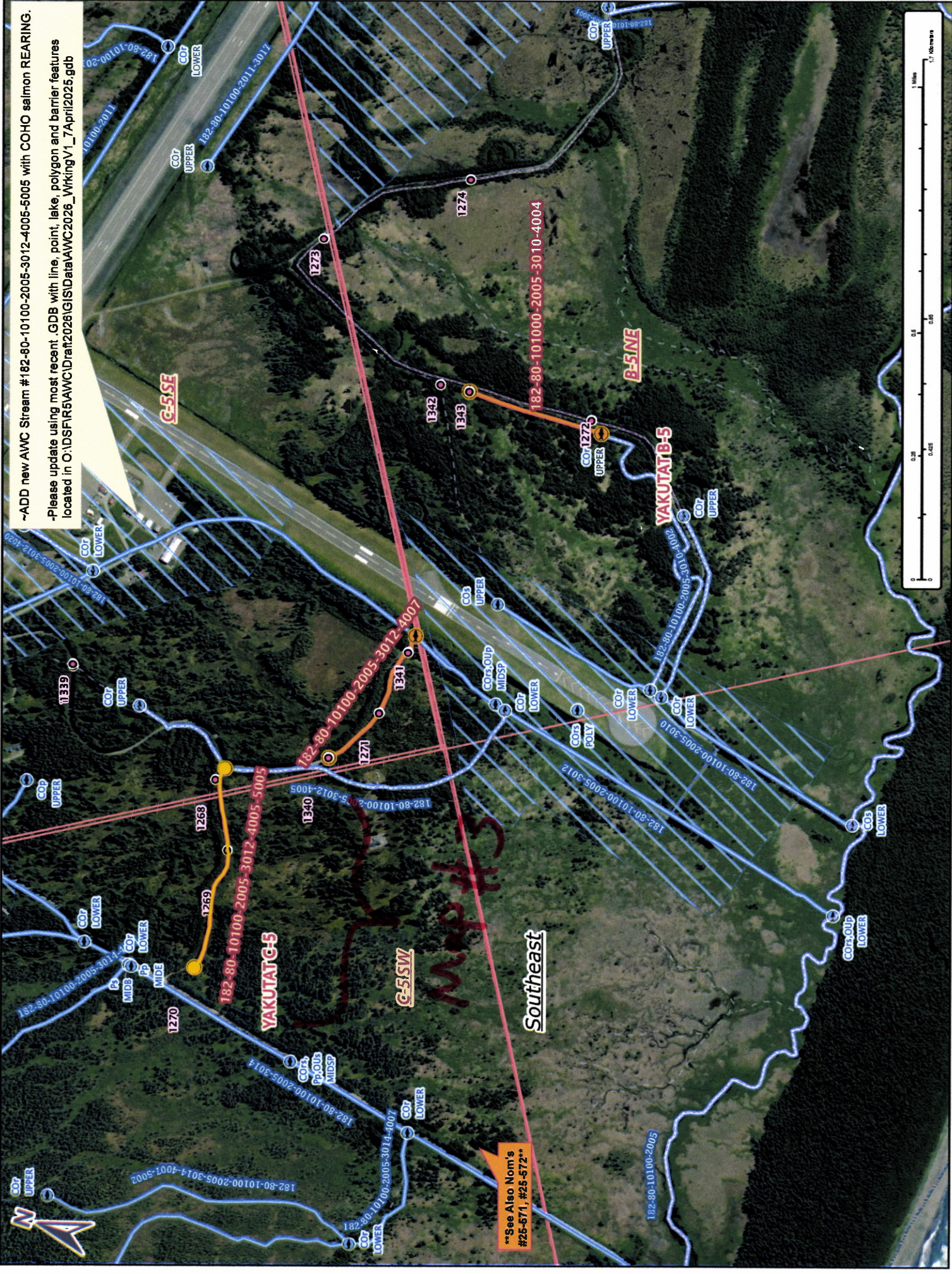


Figure 4.-182-80-10100-2005-3012-4005 tributary 1 addition map.

Recommendations: Add this uncataloged stream to the anadromous waters catalog for rearing coho salmon (Figure 4).

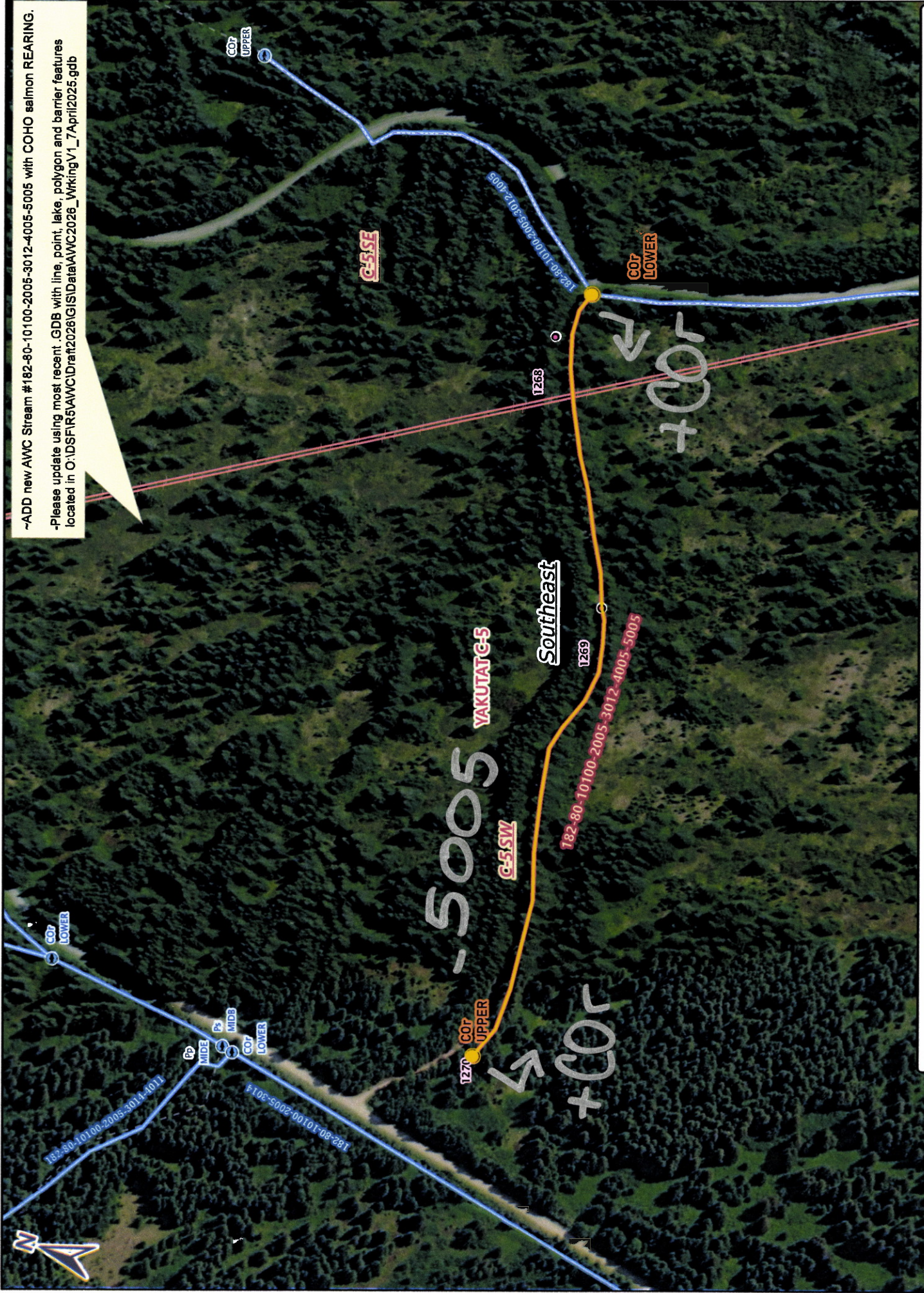
